## **Explanation of Responses:**

The remaining 355,284 shares were previously distributed to the reporting person and his spouse and continue to be included in this Form 4 as directly or indirectly (by spouse) owned.

2. 28,594 shares previously included as indirectly owned by children's trust are not included in this Form 4 because the beneficiary no longer shares the reporting person's household.
